NOTICE IS HEREBY GIVEN that at a duly called meeting pursuant to the authority set forth in the Declaration of Condominium of SANIBEL ARMS WEST, A CONDOMINIUM, recorded in O.R. Book 841, Page 619 et seq., Public Records of Lee County, Florida, as amended, and restated in the Articles Of Incorporation of Sanibel Arms West Condominium Association, Inc. (A Nonprofit Florida Corporation) recorded with the Office of the Secretary of State, Division of Corporations on 23 May 1984, the following amendment to the By-Laws of said Condominium was voted upon and passed by at least two-thirds (66 2/3%) of the association membership present at the annual meeting and after unanimous adoption of a Resolution proposing said amendment by the Board of Governors of SANIBEL ARMS WEST CONDOMINIUM ASSOCIATION, INC. held at 2:00 p.m. on November 20, 1993:

I. Paragraph 3.(.3) of the By-Laws of SANIBEL ARMS WEST, A CONDOMINIUM, pursuant to Declaration thereof, as amended, and restated in the Articles of Incorporation of Sanibel Arms West Condominium Association, Inc. (A Nonprofit Florida Corporation), is amended to read:

THE TERM OF EACH GOVERNOR'S SERVICE shall extend until his elected term is completed and thereafter until his successor is fully elected and qualified or until he is removed in the manner elsewhere provided. No Governor shall serve more than three (3) consecutive 2 year terms. At the first election two (2) Governors to be elected for a term of two (2) years and three (3) Governors to be elected for a term of one (1) year. Thereafter, as terms of office expire, vacancies shall be filled by election of Governors for a term of two (2) years for the number of vacancies occurring in that year.

(This Amendment does change present text.)
